Councilor Herrera made comments regarding Police Department uniform cleaning and car washes. Councilor Herrera would like to see the city include these items in the budget.

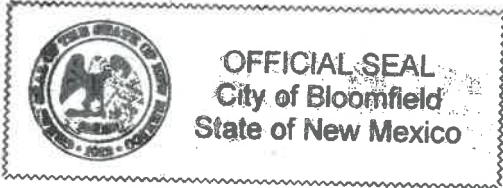
Mayor Atencio read a letter of appreciation from the cemetery board and a letter of appreciation from citizens regarding the aquatic center and staff.
