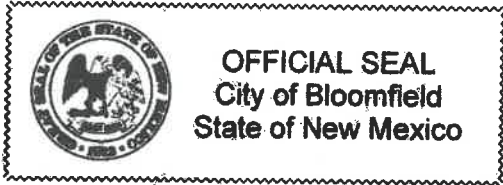
Alecs Mojica made comments regarding the speed limit signs on HWY 550 and requested to place more.
